## Why Partnerships Matter in NCCP Implementation

- NCCPs require strong partnerships for effective implementation.
- Cancer control is interconnected with NCDs, PHC, UHC, and social sectors.
- People with lived experience (PWLE) bring essential insights for patient-centered policies.
- Strategic partnerships bridge gaps in funding, workforce, and system capacity.

## Strategic Partnership Models for NCCPs

**From Planning to Execution**: Moving beyond just establishing partnerships to using them strategically for implementing priority areas in the NCCP.

- Government & Policy-Level Partnerships: Ministries of Health, National Cancer Institutes, UHC/NCD strategies (Example: Rwanda's NCD alignment).
- Health System & Clinical Partnerships: Hospitals, professional associations, training institutions (Example: India's regional cancer centers).
- Advocacy & Civil Society Partnerships: Patient groups, cancer organizations, women's health networks (Example: Kenya's PWLE-led HPV advocacy).
- Research & Academic Partnerships: Universities, global research collaborations (Example: Thailand's National Cancer Research Framework).

### Integrating People with Lived Experience as Partners

- Not just inclusion, but power-sharing: PWLE as co-designers in policy, research, and service
  delivery.
- From consultation to leadership: Moving beyond tokenism into sustained roles (e.g., advisory boards, co-authorship, implementation teams).
- Strengthening health system accountability: PWLE perspectives ensure policies align with real-world needs.
- Meaningful Engagement in Action: Establishing clear roles, compensation, and influence in decision-making.
- Global Best Practices: WHO's Meaningful Engagement Framework, Cancer Australia's consumer advisory model, and successful regional PWLE-driven initiatives can provide guidance.

# Leveraging Existing Partnerships for More Impact

- NCD & Primary Health Care (PHC) Integration Avoid siloed approaches, embedding cancer within broader health priorities enhances efficiency.
- Linking to Universal Health Coverage (UHC) Aligning cancer care with health financing mechanisms supports sustainability.
- Cross-border & Regional Collaborations Regional initiatives enhance learning and policy alignment.
- Mobilizing Private Sector Resources Pharma, diagnostics, and tech partnerships for capacity building and innovation.

## Overcoming Challenges - Doing More with Limited Resources

- Shared Funding & Cost-Sharing Pooling resources with NCD/UHC programs ensures efficiency.
- Task-Shifting & Capacity Building Training non-oncology professionals expands workforce capabilities.
- Leveraging Community Networks Engaging civil society, religious groups, and grassroots organizations extends reach.
- Data & Evidence Sharing Strengthening data collection for informed policy and program decisions.

## Country-Level Examples of Effective Partnerships

### **Rwanda** – Integrating Cancer Control into NCD Programs

- Multi-sector collaboration between government, civil society, and research institutions.
- Policy alignment with NCD/UHC frameworks enabled sustainable expansion.

### Kenya - PWLE-Led Advocacy for National Cancer Control - KENCO

- Patient organizations successfully mobilized HPV vaccination funding.
- PWLE integrated into policy development and implementation teams.

#### Australia - Structural Inclusion of PWLE in Cancer Planning

- Cancer Australia's national strategy embeds PWLE engagement at every policy level.
- Consumer advisory groups have institutionalized roles in decision-making.

## Practical Steps - Strengthening Partnerships in NCCPs

- Map Existing Partnerships Identify gaps and opportunities across different levels.
- Formalize PWLE Involvement Establish structured advisory roles, not just one-off consultations.
- Leverage NCD & UHC Platforms Integrate cancer into broader health priorities for sustainable funding.
- Develop Accountability Mechanisms Set partnership KPIs to track engagement and effectiveness.
- Foster Cross-Sector Collaboration Engage education, digital health, and community groups for broader impact.

Embedding partnerships and PWLE engagement in NCCPs isn't just a best practice—it's essential for impact.

- Cancer control is **bigger than any one sector**—leveraging partnerships is key to sustainable implementation.
- PWLE bring invaluable knowledge that makes policies more effective and responsive to real needs.
- Strong partnerships don't require more funding—they require smarter collaboration.
