- Cervical cancer elimination strategy activities to achieve the 90-70-90 by 2030.
- Implementation of second National Cancer Control Strategic Plan
- Increase the prevention services (Awareness, HPV vaccination, screening and precancer treatment services)
- Capacity-building for childhood cancers (on early identification, referral pathway, diagnosis, treatment and survivorship).
- Strengthen the quality of confirmed cancers (cancer registry)
- Establishment of Radiotherapy treatment centre
