ABOUT THE INTERNATIONAL CANCER CONTROL PARTNERSHIP

A group of international organizations, already individually engaged in cancer control planning efforts, developed the ICCP in 2012. The Partners are seeking to create synergies in a united approach to maximise collective resources and efforts to support National Cancer Control Plans (NCCPs) development, implementation, and evaluation.

The long-term outcome that the ICCP is working towards is that all countries have and are implementing a quality cancer control plan, which is linked to a country's non-communicable disease (NCD) control efforts. The ICCP believes that prioritizing cancer is critical to reaching the NCD goal within the Global Monitoring Framework on NCDs, the WHO Global Action Plan on NCDs and the UN Sustainable Development Goals.

VISION

All countries have and are implementing an equity-oriented, person-centered, context appropriate NCCP.

MISSION STATEMENT

The ICCP coordinates expertise and guidance to national cancer control planning stakeholders and decisionmakers in their efforts to develop, implement and evaluate data-driven, stakeholder-informed, and equity-oriented national cancer control plans. ICCP efforts are integrated and in alignment with the United Nations Sustainable Development Goals to reduce premature mortality from non-communicable diseases including cancer.

PARTNERSHIP GOALS

The main goals of the ICCP are:

- Coordinate and leverage partner efforts to increase global support, political will, and country resources for development and implementation of NCCPs
- Provide guidance to countries as they strengthen their capacity to develop, implement and evaluate NCCPs
- Maintain and enhance the ICCP as a credible source of guidance and leadership in national cancer control planning

TECHNICAL ASSISTANCE

ICCP provides various types of collaborative technical assistance support for countries around the development, implementation, and monitoring and evaluation of NCCPs, including:

- Assistance with development of NCCPs and implementation plans
- Reviewing, evaluating, providing feedback on drafts of NCCPs
- Assistance with updating expired or soon-to-expire NCCPs
- Expertise and/or connection to an expert on a specific area of cancer control, for example: pathology
- ICCP ECHO telementoring program on NCCP implementation
