STAKEHOLDERS ENGAGEMENT CONTINUES

- LOCAL CLINICAL SPECIALISTS ALSO HAVE A MEETING WHERE THEY DISCUSS RESPECTIVE
 PATIENTS WITH THE ONCOLOGIST ?TUMOUR BOARD (USING MAINLY WHATSAPP BECAUSE
 OF COVID19)
- NURSES NAVIGATORS WERE RECRUITED BY NCCP TO ASSIST PATIENT WITH GETTING HOSPITAL SERVICES TIMEOUSLY, INTERDEPARTMENTALLY FOR SPECIALIST CARE. NO MORE PATIENTS ARE GETTING LOST FROM THE SYSTEM OR TREATMENT DELAYS. THEY CALL PATIENTS WHO MISSED APPOINTMENT AND THOSE FOUND TO HAVE NOT COMPLETED THEIR HOSPITAL CONSULTATIONS.
- **PSYCHOSOCIAL SUPPORT** OTHER THAN THE CANCER, PATIENTS GET EMOTIONAL, ECONOMIC SUPPORT ETC.



- SPECIALISTS RECRUITED AND CAPACITY BUILDING ONGOING THROUGH WEEKLY CLINICAL MEETINGS.
- SCREENING FOR EARLY DETECTION, HAS PAST STAGE OF DEVELOPING SOPS AND TRAINING PROVIDERS TO IMPLEMENTATION
- CERVICAL AND PROSTATE CANCER AWARENESS AND SCREENING CAMPAIGNS AT REGIONAL LEVEL WAS A VERY SUCCESSFUL ACTIVITY. 16 WERE DONE IN 3 MONTHS.
